**PROCUREMENT OF NEW MIDIBUSES FOR SCHOOL CHILDREN TRANSFER**

This Invitation for Tenders follows the General Procurement Notice for this project which was published on the EBRD website, Procurement Notices ([www.ebrd.com](http://www.ebrd.com)) on 08/07/2016.

The municipal transport company Gradsko Saobracajno Preduzece (or **JKP GSP „Beograd“**) hereinafter referred to as “the Purchaser”, intends to use part of the proceeds of a loan from the European Bank for Reconstruction and Development (the Bank) towards the cost of Bus Renewal Programme – restructured - 44014

The Purchaser now invites sealed tenders from Suppliers for the following contract to be funded from part of the proceeds of the loan: Procurement of 12 new midibuses with minimum 30 **seats for school children transfer**. Tendering for contracts that are to be financed with the proceeds of a loan from the Bank is open to firms from any country.

To be qualified for the award of a contract, tenderers must satisfy the following minimum criteria:

- Experience as Supplier, in at least **three (3)** contracts within the last **five (5)** years, that have been successfully and substantially completed and that are similar to the proposed Goods. The cumulated number of midibuses supplied, as reflected in all the contracts indicated as reference for the experience as a Supplier of similar goods, shall be minimum **thirty (30)**. The cumulate value of all these contracts shall be minimum **EUR 2 million equivalent**.
- Average annual turnover as prime Supplier (defined as billing for Goods and Services delivered and under delivery) over the last **three (3)** years of: **EUR 2 million equivalent**.
- Access to, or has available, liquid assets, unencumbered real assets, lines of credit, and other financial means sufficient to meet the production cash flow for the contract estimated as not less than **EUR 500,000 equivalent**.

Tender documents may be obtained from free of charge in electronic version from the office at the address below upon submission of a written request providing the following information:

- the name and address of the company intending to submit a tender;
- the name, tile, phone, phone, fax and email address of the person responsible on behalf of the company for this tender;
- the email address where the tender documents in electronic format shall be sent, and
- any alternative email where the tender documents and further correspondence related to this tender shall be sent

Upon receiving written request including all the above mention the documents will be promptly dispatched by email at the email address(es) indicated in the request. The perspective tenderer shall be responsible for the correctness of the e-mail address and the capacity to receive tender documents on electronic format.

All tenders must be accompanied by a tender security of **EUR 20,000** or its equivalent in a convertible currency.

Tenders must be delivered to the office at the address below on or before 05/12/2016 at 10.00 hours local time, at which time they will be opened in the presence of those tenderers’ representatives who choose to attend.
